








The new Valuing Ontario

The SROI uses a cost-based approach to analyse direct spending, direct tangible benefits and indirect tangible benefits.


## Social Return on Investment

- 7. Space



Public library services play a critical role in providing access to information, education, and cognitive development; filling gaps left by schools and the formal education system or supporting adult learners pursuing formal or informal education.

Public libraries support education in a variety of ways, from helping parents and guardians facilitate the intellectual and social growth of their children, to facilitating universal access to multiple and varying forms of literacy and educational opportunities.

- Economic benefit of access to information.
- Economic benefit of children and teens programming.
- Economic benefit of class instruction at a library or a school.




Public libraries contribute to increasing cultural vitality through connecting (or reconnecting) us to the unique ways of life of diverse peoples, as well as the cultivation of a sense of local identity and place. Public libraries symbolize local autonomy through the maintenance of local history and special collections, advertising events that characterize place, and hosting cultural events. Many provide unique access points to a myriad of cultural practices, from Indigenous language collections to environmental interventions, such as seed libraries.

- Economic benefit of special collections and other materials related to the culture and the history of the area.
- Economic benefit of the promotion of local cultural and historical events, programs, advertising space and information services about the local area.
- Economic benefit of cultural events.



Public libraries foster social inclusion and wellbeing by providing services with equitable access to critical resources, technology, and information. They provide opportunities for self-care, information to support healthy living, and connections to resources that foster a sense of belonging and security. They also assist in leveling the economic playing field, providing people of all incomes with access to costly resources.

- Economic benefit of accessible collections (i.e. Braille, large print books, Talking Books on CD, etc.).
- Economic benefit of internet access.
- Economic benefit of social and health-related programming delivered at the public library.



Public libraries provide a variety of spaces for community activities and connections. Space for individuals to gather and organizations to meet enriches lives, builds networks, and helps to craft a sense of belonging. Special purpose spaces offer people opportunities that few have access to privately, whether it be for entertainment and recreation or professional development.





# Community Profile




## Library Traffic and Usage





Our cardholders and program demand will grow as our community grows


#### Projected Demand: Cardholders & Programs

#### **Projected Visits & Circulation**




## Building Needs Assumed Population

## BMPL Expansion Summary

- 2010 -2022 multiple needs assessments and feasibility space studies for Library were conducted.
- Councils have acknowledged the requirement of expanded space for BMPL.
- Development Charges have been accrued in recognition of this need.
- Population projections and community demand indicate that our current space at LE Shore will be insufficient to support the current community; let alone the fastgrowing future resident base.
- At ARUPLO's standard of 1sqft/pp, we are just meeting this currently (considering permanent residents).



## Recommendations

That Council receives the Blue Mountains Public Library Board's Needs Assessment and Usage Report, November 2023 and the Board presentation in response to the June 14, 2023, Joint Meeting; and

That Council direct Town staff to include the expanded library services in the Multi-Use Feasibility Study, and to include the Library CEO to be a member of the RFP Committee and Study Committee.
